I submit that, the Regional Joint Director of School Education, Kadapa has submitted the proposal for grant of permission for shifting of school i.e., Academic Heights EM High School, D.No.8-36/6, Plot No.153-A, Bypass Road, M.R.Palle Circle, Tirupati District to be shifted to Academic Heights EM High School, Sy.No.210/1, Sub division 210/1B2, 210/2, 206/A2/C2/B & 206/C/1, Pudipatla Village, Perumalapalli Gram Panchayat, Tirupati Rural Mandal, Tirupati District for classes I to X (EM) from the academic year 2025-26 vide reference 9th cited.

Further, I submit that the Regional Joint Director of School Education,

Kadapa has stated that, the management has fulfilled all the conditions and providing better accommodation. But sub rule (22) of Rule 10 of G.O.Ms. No. 1, Education Department, dated 01- 01-1994 envisages that, "shifting of the institutions from one locality to another will not be permitted under ordinary circumstances, as a matter of routine. However, shifting of the institution from one building to another within the same locality of within the same Town / Municipal Limits may be permitted when the intention is to provide better accommodation or shifting into own building is proposed". Here the management of the Academic Heights EM High School submitted proposal for shifting of the school from one Mandal to another Mandal. i.e. Tanapalli Road, Tiruchanur Village, Tirupati Rural Mandal, Tirupati District to Road.No.2, Mohan Reddy Nagar, Elamandyam Village, Pillapalyam (PO), Renigunta Mandal, Tirupati District from the academic year 2025-26. Further, the Government is the competent authority to relax rules and accord shifting permission as proposed by the management and as well the District Educational Officer, Tirupathi and the Deputy Educational Officer, Tirupati.

In this regard, I submit that the Regional Joint Director of School Education, Kadapa has requested to grant of Permission to shifting of School i.e., Academic Heights EM High School, D.No.8-36/6, Plot No.153-A, Bypass Road, M.R.Palle Circle, Tirupati District to be shifted to Academic Heights EM High School, Sy.No.210/1, Sub division 210/1B2, 210/2, 206/A2/C2/B & 206/C/1, Pudipatla Village, Perumalapalli Gram Panchayat, Tirupati Rural Mandal, Tirupati District for classes I to X (EM) from the academic year **2025-2026**.

After careful examination of the proposals received vide reference 5th cited and recommendations of the Inspecting Officer vide reference 6th cited and conditions prescribed in Govt. orders read above, the competent authority i.e., the District Educational Officer, Chittoor hereby accords for grant of **Renewal of Recognition in respect of Academic Heights English Medium Primary School, AIR By Pass Road, M.RPalle Circle, Tirupathi** for Classes I to V English Medium for the period from 2017-2018 to 2026-2027 without aid to the following conditions:

- 1] That the society shall abide by the instructions/rules and regulations made by the Government of authorities Officer from time to time.
- 2] That the Educational Institution shall serve the needs of the locality more particularly.
- 3] That the instructions shall adopt the curriculums and syllabus prescribed from time to time.
- 4] The school timings vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
- 5] That the qualified staff within the age limits prescribed by the Government for Govt. Employees shall be appointed as per the staff pattern.
- 6] That the results of the Institutions shall be satisfactory every year.
- 7] That the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.

- 8] That the list of Governing Body shall be furnished to the Educational Officer every year.
- 9] Only single section is permitted
- 10] That the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
- 11] That all the conditions prescribed in the G.O.s and others which are not specified in these orders shall be compiled with.
- 12] That the school shall not be closed without giving notice both to the parents/District Educational Officer and competent authority at least for 6 months before.
- 13] That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 14] The management should get electrical wiring checked as a measure of safety of the students.
- 15] The society shall submit proposals for renewal of recognition at least 6 months prior to the date of expiring of the orders. These orders are liable for withdrawal / cancellation at any time for non-fulfillment of conditions of T.R.
- 16] The management may be instructed to submit the latest occupancy No Objection Certificate issued by the Fire Department Authorities within six months without fail.
- 17] The management should adhere the instructions issued by the District Educational Officer, Chittoor time to time.
